Your Session Fee Includes:

- Pre portrait consultation to bring forth ideas and input to ensure a successful session.
- A selection of props for your session.
- Up to 2h (45min for mini session and 2-4h for newborn session) of coverage on your session day.
- Post session image preparation.
- Online password protected gallery with approximately 20 images to order your products from.

Studio Polices & Terms

1. The session fee pays for the time and talent of the photographer and for the preparation of your on line gallery. It does not include any finished portraits. The session fee is due at the time of booking and is non refundable, however within 48h notice it can be rescheduled in case of emergency.
2. If your child is sick on the day of session, please make sure to reschedule if you try to keep the appointment. Sick children do not like being photographed and it is very probable that you would not love your portraits nearly as much as if they were in good health.
3. Please bring only people who are meant to have their photographs taken. It is extremely important with children as the photographer needs their full attention rather than them looking at other members of family. Of course parents are always welcome!
4. It is strictly prohibited to take photographs with your mobile devices or cameras / camcorders during the photo session with Artistic Child Photography.
5. You agree to hold harmless Agnieszka Lawniczek, her representatives, employees and Artistic Child Photography from any dispute in the event of you, your child or any other person becoming injured during your session or while on studio premises. Artistic Child Photography and its representatives will not be held liable for any injury incurred by you and your family or any damage to your property during the photo session or while on studio premises.
6. £250.00 deposit towards your product order is required before or on a day of the session. It will then be deducted from your final order. Product deposit is not transferable and not refundable in the unlikely event when you do not wish to order any products. It is to cover 30-40h editing time required to prepare the gallery of 20 portraits.

7. The proof images will be delivered to client via password protected online gallery within 4-8 weeks from the session date. The gallery will be available for 48h for you to choose your favorite images and products. There is a £25 fee to reload your images for additional 24h once the gallery has expired. All unordered and unhonored images are purged after 30 days from the time when the gallery goes live.
8. While Artistic Child Photography captures many images during your session, the Photographer reserves the right to pick approximately the best 20 images to present to the client in online gallery. The selection made is based on Photographer's experience and artistic vision. The client is not involved in the selection process. Each image is carefully rendered to ensure technical perfection and maximum artistry. Images with eyes closed, head turned and duplicates will not be shown and are removed from the archives permanently after the artist rendering is complete.
9. The gallery must be opened within 14 days from the notification email.
10. Due to the custom nature of work, a payment for your order must be placed in full and is subject to 50% cancellation fee should you change your mind once your order has been placed. Once the order has been sent to the lab, it is deemed non-refundable. Payment for your order is due upon receiving a final invoice during the 48h period while your online gallery remains live.
11. Please allow approximately 3 weeks for your order to be completed and available for pick up. Some orders may take longer. Your portraits are an investment and an heirloom that should not be rushed. If you are unable to pick your order up, Artistic Child Photography is happy to arrange for the courier at the additional cost (£10 for UK orders under 5kg) and at client responsibility and risk. Artistic Child Photography and it's owner shall not be liable for any loss, deterioration and damage to clients order after personal pick up or courier collection. You will be notified by email once your order is ready.
12. All ordered images are kept on our file for a period of 1 year. Unordered images are removed from our archives after 30 days.
13. The Photographer keeps the copyright of all photographs as per Copyright, Designs & Patents Act 1988 and hereby issues the Client unlimited but non-exclusive rights to use or reproduce the purchased photographs for personal purposes only.
14. The Copyright Act protects the photographers by giving us the exclusive rights to reproduce your photographs. Violations include, but are not limited to, making illegal copies, scanning, printing from home or downloading from our website. It is illegal to copy or reproduce these photographs without our permission and violators of this law will be subject to civil and criminal penalties. Please understand the Photographer wishes to maintain control over the print quality, finishes and presentation of the images as any reproduction outside the studio may lower the quality of the image and scar our reputation for providing superior portraits.
15. Artistic Child Photography reserves the right to use any photograph in any form such as, but not limited to, the use in advertising, reproduction and copyright including but not limited to portfolio, website, social media, photography competitions, ads in magazines, exhibits or displays. The work is always showcased in best possible way and will never compromise and jeopardies the Photographer's hard earned reputation. Confidentiality in advertising is always maintained.
